#### Local action towards HELCOM targets/BSAP

- What local socio-economic and environmental benefits can be captured by municipalities by working closer with HELCOM goals and objectives?
- Using the background paper for Workshop 2 as a starting point what would the relevant and possible avenues be for closer engagement between municipalities and HELCOM goals and objectives?

#### **Communication and public awareness**

- What are the benefits and challenges of communicating with citizens and other BSR municipalities about work on clean water/Baltic Sea issues?
- How could communication between HELCOM, municipalities and cities be improved around HELCOM targets and Baltic Sea Health?
- What would possible common indicators be that municipalities could report on and share with their citizens, other municipalities and other BSR stakeholders to demonstrate their efforts and results? [towards HELCOM BSAP goals/objectives or other common report card, e.g. EcoCheck example]?

#### Monitoring and reporting effectiveness of measures

- How are measures to reduce impact on the Baltic Sea being selected, evaluated/monitored and reported on currently?
- What are the benefits & challenges around monitoring and reporting the effectiveness of specific measures?
- Would municipalities be interested in a list of recommended measures from HELCOM?
- Give input to the Workshop 2 background paper. What monitoring and reporting is relevant and feasible from the city/municipality point of view?
- What are the benefits and challenges of sharing data (specifically for data on effectiveness of measures) with other municipalities, national authorities, regional organisations, e.g. HELCOM, or other organisations such as RFTB, Baltic Sea Challenge, etc.?
