How are we all doing? 2020 Network Assessment

In April 2020, SIWI undertook an assessment of the Women in Water Diplomacy Network. The aim was to better understand the needs and priorities of Network members.

The results were exciting. Network participants see value in the Network, use and share information gained through the Network, and strongly believe the Network contributes to improved transboundary water cooperation at the country level, at the sub-Basin level, and at the Basin level. There is a clear desire to continue to utilize and expand the Network over the coming months and years!

The Network members are keen to take on new challenges and leverage opportunities to grow the Network—particularly looking to improve linkages to other water diplomacy initiatives in Africa, engage more young professionals in water diplomacy processes, continue joint learning through Network meetings, create opportunities for inter-basin experience exchange, and engage more of the Nile's growing number of women water diplomates in the Network.

I was able to present a paper that articulated how we use human rights approach in water programs by addressing issue of gender, People with Disability, People Living with HIV and AIDS, refugees, poverty issues through the pro poor strategy and more importantly recognition that access to water is a human right as enshrined in the Ugandan Constitution and the water statute."

Women in Water Diplomacy Network Issues Joint Statement:

In January 2020, during the 3rd annual Women in Water Diplomacy workshop in Naivasha, Kenya the assembled women water leaders of the Nile basin states released a unique 'Joint Statement' in support of enhanced inclusive transboundary water cooperation.

The Statement, complementing high level processes ongoing in the Basin, called attention to the importance of inclusive water governance across the Nile and stressed the 'urgency of action to address our shared water and climate challenges.'

The statement was endorsed by all of the workshop participants.

Opportunity for Engagement: '(En)Gendering Transboundary Water Governance: Feminist Perspectives on Water Conflict and Cooperation'

On 29 and 30 September 2020, IHE Delft will host an online cross-regional workshop on '(En) Gendering Transboundary Water Governance: Feminist Perspectives on Water Conflict and Cooperation.'

The Women in Water Diplomacy Network will share their experience during the conference in a SIWI facilitated panel featuring three Network members including **Yodit Balcha**, Climate Change Adaptation Advisor,

Ministry of Water, Irrigation, and Energy, Ethiopia; **Nancy Ngumba**, MFA, Peace and Conflict, Kenya, and a third surprise speaker, to be confirmed.

The workshop aims to bring together researchers and practitioners to shed light on the often hidden gender dynamics of water conflict and cooperation at transboundary level and on the implicit assumptions that guide research as well as policies. The conference will discuss

strategies to support more inclusive water diplomacy.

ELI's Jessica Troell has been engaged in supporting the Network since its inception and this new MOU will enable broader ELI support to the Network in this new phase. We are excited to expand this critical partnership and for ELI to bring its extensive expertise in national and transboundary water law and governance to enhance the activities and capacities of the Network.



Joint Research featuring Women in Water Diplomacy to be released soon:

SIWI's Shared Waters
Partnership programme,
SIWI's UNESCO Category
II Centre - the International Center for Water
Cooperation (ICWC), and
IHE Delft Institute for
Water Education have
conducted a study on
women's participation in
high-level decisionmaking processes related
to transboundary water
management.

The aim of the study is to contribute to a better understanding of high-level decision-making processes on water from a gendered perspective, identify the barriers and opportunities women encounter and based on this develop recommendations to strengthen inclusive decision making.

The three geographic areas included in the

study are Chu Talas basin, the Rhine basin and the Nile basin.

The results will be presented in a webinar **5 Octo- ber**, with the three researchers Alexandra Said (SIWI), Rozemarjin ter Horst (IHE Delft) and Jenniver Sehring (IHE Delft). Additionally the event will feature a panel discussion with three experts from the respective basins.





Experience Sharing: Dr. Tahani Sileet featured in Shared Waters Partnership Webinar Series

SIWI's Shared Waters Partnership (SWP) programme initiated its special webinar series for basin partners in April 2020 as a part of the SWP response to the COVID-19 pandemic.

The second SWP webinar focused on enhancing inter-ministerial coordination for improved transboundary cooperation and featured a key member of the Women in Water Diplomacy Network, Dr. Tahani Sileet.

Dr. Sileet shared insights and experience from her many years of high level leadership in Nile Basin processes. Remarking on the issue of interministerial coordination that 'the key factors for intergovernmental coordination in Egypt are, political will and respecting the principle of water law.'

Adding, 'the overall necessity of intergovernmental

coordination is needed on both in national and regional level.'

The SWP Webinar series continues on September 8 with 'Digital Water Diplomacy.'

Women in Water Diplomacy Network Joint Statement-Full Text

January 23, 2020

Women in Water Diplomacy in the Nile Basin, 2020

On this day January 23, 2020, we, women water leaders from Nile Basin states conclude our participation in the Third Annual Women in Water Diplomacy Workshop hosted with appreciation by the Shared Waters Partnership programme at Stockholm International Water Institute (SIWI). Together, we recognize the unique and intrinsic social, cultural, ecological, and economic value of the Nile Basin and its essential role and relevance in all aspects of our lives and communities. It is due to this shared heritage that we join together to elevate our voices in sisterhood, as peacemakers, mediators, and water stewards. Evidence from water cooperation and peacebuilding efforts throughout the world has demonstrated that women play an essential role in the provision, management, and safeguarding of water as well as ensuring a more durable peace.

Cooperation over the shared water resources of the Nile Basin is essential to sustainable water management and realization of the Sustainable Development Goals (SDGs) throughout the Basin. To mitigate and manage potential and actual drivers of water-related challenges in the region, more inclusive decision making is critical. Specifically, this necessitates the importance of enhancing women's role as decision makers. We are blessed with a strong and knowledgeable generation of women water leaders across the Basin. We call upon our fellow decision makers to leverage all available skills, experience, and leadership to improve cooperation across the Basin and achieve our shared goals of sustainable water management and development.

We share a cooperative vision for the Nile Basin – a vital life-force across our communities and countries. As water leaders and professionals, we recognize the remaining challenges that weigh heavy on our peoples. The path towards sustainable water management has been long and difficult at times - but also one rich with opportunities. Despite the challenges, we are bound together and thus recognize the significant benefits to regional development and economic integration that can result from improved transboundary cooperation. In our Workshop, we discussed common challenges, enhanced our understanding of each other and our countries, and together sought to identify mutually beneficial opportunities for cooperation. These opportunities include, but are not limited to, increasing our resilience to climate change impacts through improved watershed management and water use efficiency, as well as efforts to reduce pollution of our shared water resources.

In this call, we stress the urgency of action to address our shared water and climate challenges. We agree, in our capacity as women water leaders, to continue to work together to further cooperation as well as contribute to the enhancement of inclusive decision making across the Nile. We call for sustained support and partnerships at home and across the international community in these critical endeavors.
